

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 Department of Education Child Care Services Child Care and
Development Fund-Discretionary Carry Forward Budget)**

RESOLUTION NO. 22-303

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Education has prepared and submitted for review and
8 approval its FY 2022 Child Care Services ("CCS") Child Care and Development
9 Fund ("CCDF")-Discretionary Carry Forward Budget, which is incorporated by
10 this reference, in the amount of \$1,552,197.01 to be funded from the U.S.
11 Department of Health and Human Services, Administration for Children and
12 Families, Office of Child Care; and

13 **WHEREAS,** the Human Resources Development Committee and Budget and Finance
14 Committees have reviewed the FY 2022 Department of Education CCS CCDF-
15 Discretionary Carry Forward Budget and recommend its approval.

16 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
17 FY 2022 Department of Education CCS CCDF-Discretionary Carry Forward Budget
18 effective October 1, 2021, in the amount of \$1,552,197.01, which shall be funded
19 by the U.S. Department of Health and Human Services, Administration for
20 Children and Families, Office of Child Care.

21 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
22 Nation chairperson or any designated official is authorized to administer and
23 expend the FY 2022 Department of Education CCS CCDF-Discretionary Carry
24 Forward Budget, provided that any amendments or modifications shall be
25 submitted for prior approval by the Tohono O'odham Legislative Council.

26 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH
27 day of AUGUST, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-
28 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by,
29 Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by
30 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
31 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
32 18, 1934 (48 Stat.984).
