

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 Department of Health and Human Services Division of
Community Health Services Haury Grant Project Carry Over Budget)**

RESOLUTION NO. 22-307

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for
8 review and approval its FY 2023 Division of Community Health Services Haury
9 Grant Project Carry Over Budget, which is incorporated by this reference, in the
10 amount of \$9,728.65 to be funded by the Agnese N. Haury Seed Grant; Arizona
11 Board of Regents, University of Arizona, College of Agriculture & Life Sciences,
12 Department of Entomology and Insect Sciences; and

13 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
14 reviewed the FY 2023 Department of Health and Human Services Division of
15 Community Health Services Haury Grant Project Carry Over Budget and
16 recommend its approval.

17 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
18 FY 2023 Department of Health and Human Services Division of Community Health
19 Services Haury Grant Project Carry Over Budget effective January 1, 2022,
20 through December 31, 2022, in the amount of \$9,728.65 which shall be funded by
21 the Agnes N. Haury Seed Grant; Arizona Board of Regents, University of Arizona,
22 College of Agriculture & Life Sciences, Department of Entomology and Insect
23 Sciences.

24 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
25 Nation chairperson or any designated official is authorized to administer and
26 expend the FY 2023 Department of Health and Human Services Division of
27 Community Health Services Haury Grant Project Carry Over Budget, provided
28 that any amendments or modifications shall be submitted for prior approval by
29 the Tohono O'odham Legislative Council.


