

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Enrollment Resolution No. 08-330, "Approving Enrollment or Adoption
Applications for Membership in the Tohono O'odham Nation for June 2008,"
to Delete Members who were Approved Twice)**

RESOLUTION NO. 22-317

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power to enact laws
2 and ordinances governing the enrollment and adoption of members
3 (Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and
4 Section 1(h)); and

5 **WHEREAS,** pursuant to Articles VI and VII of the Nation's Enrollment Ordinance, the
6 Enrollment Committee shall review membership applications and make a
7 written recommendation to the Legislative Council to approve or reject the
8 application (14 Tohono O'odham Code Chapter 1 – Enrollment Ordinance); and

9 **WHEREAS,** the Enrollment Program has determined that members were originally approved
10 for membership by Resolution No. 07-739; and

11 **WHEREAS,** the Enrollment Program discovered that these same members were mistakenly
12 approved a second time for membership by Resolution No. 08-330; and

13 **WHEREAS,** the Enrollment Program recommends that Resolution No. 08-330 be amended to
14 delete members identified in the Amending Enrollment Resolution List
15 September 2022, which is incorporated by this reference; and

16 **WHEREAS,** the members that were originally approved in Resolution No. 07-739 will retain
17 the roll numbers and approval dates identified in that resolution.

18 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council amends
19 Resolution No. 08-330, "Approving Enrollment or Adoption Applications for
20 Membership in the Tohono O'odham Nation for June 2008," upon the effective
21 date of that resolution by deleting members and corresponding information
22 identified in the attached Amending Enrollment Resolution List September 2022.

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH**
24 **day of SEPTEMBER, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**
25 **-0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by,**
26 **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono O'odham**
27 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
28 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
29 **16 of the Act of June 18, 1934 (48 Stat.984).**
