

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Accepting Institute of Museum and Library Services Native American Library Services Basic Grant and Approving FY 2023 Department of Education Institute of Museum and Library Services Native American Library Services Basic Grant Budget)

RESOLUTION NO. 22-319

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Education Venito Garcia Library has applied for and received
8 the Native American Library Services Basic Grant Award No. NAB-252269-OLS-22
9 in the amount of \$10,000.00 from the Institute of Museum and Library Services
10 ("IMLS") Native American Library Services; and

11 **WHEREAS,** the Department of Education has prepared and submitted for review and
12 approval its FY 2023 Department of Education IMLS Native American Library
13 Services Basic Grant Budget, which is incorporated by this reference, in the
14 amount of \$10,000.00 to be funded by the Nation's general fund pending
15 reimbursement from the Institute of Museum and Library Services ("IMLS")
16 Native American Library Services; and

17 **WHEREAS,** the Human Resources Development and Budget and Finance Committees have
18 reviewed the FY 2023 Department of Education IMLS Native American Library
19 Services Basic Grant Budget and recommend its approval.

20 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council accepts the
21 Institute of Museum and Library Services Native American Library Services Basic
22 Grant Award No. NAB-252269-OLS-22 and approves the FY 2023 Department of
23 Education IMLS Native American Library Services Basic Grant Budget effective
24 August 1, 2022 in amount of \$10,000.00, which shall be funded by the Nation's
25 general fund pending reimbursement from the Institute of Museum and Library
26 Services native American Library Services.

27 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
28 Nation chairperson or any designated official is authorized to administer and
29 expend the FY 2023 Department of Education IMLS Native American Library
30 Services Basic Grant Budget, provided that any amendments or modifications
31 shall be submitted for prior approval by the Tohono O'odham Legislative Council.
