

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 - 2024 Judicial Branch New Probation Building Budget
Amendment No. 2)**

RESOLUTION NO. 22-329

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation...and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2021 Judicial Branch New Probation Building Budget in the amount of
8 \$2,042,909.86 was approved by Resolution No. 20-379 and subsequently amended
9 as the FY 2022 Judicial Branch New Probation Building Budget by Resolution No.
10 21-465; and

11 **WHEREAS,** the funding period for the FY 2022 Judicial Branch New Probation Building
12 Project Budget is scheduled to end on September 30, 2022; and

13 **WHEREAS,** the Judicial Branch is requesting to extend the budget period for FY 2022 Judicial
14 Branch New Probation Budget to September 30, 2024; and

15 **WHEREAS,** the Judicial Branch has prepared and submitted for review and approval its FY
16 2022 Judicial Branch New Probation Building Budget Amendment No. 2 which is
17 incorporated by this reference to extend the budget period; and

18 **WHEREAS,** the FY 2022 Judicial Branch New Probation Building Budget amount of
19 \$2,042,909.86 will not change; and

20 **WHEREAS,** the Judiciary and Budget and Finance Committees have reviewed the FY 2022 New
21 Probation Building Budget Amendment No. 2 to extend budget period and
22 recommend its approval.

23 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
24 FY 2022 Judicial Branch New Probation Building Budget Amendment No. 2 in the
25 amount of \$2,042,909.86, to extend the budget period to September 30, 2024.

26 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the chief judge or any
27 designated official is authorized to expend and administer the FY 2022 Judicial
28 Branch New Probation Building Budget, provided that any amendments or
29 modifications be submitted for prior approval by the Tohono O'odham
30 Legislative Council.
