

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointing Camillus Lopez to the Election Board for a Term Ending July 31, 2026)

RESOLUTION NO. 22-337

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power to "provide for,
2 appoint, or provide for the appointment of, and prescribe the duties and powers
3 of committees, boards, officers and agents" (Constitution of the Tohono O'odham
4 Nation, Article VI, Section 1(b)); and

5 **WHEREAS,** the Tohono O'odham Nation's Elections law, codified at 12 Tohono O'odham Code
6 Chapter 1, authorizes the Tohono O'odham Legislative Council to appoint five
7 bilingual members of the Tohono O'odham Nation to the Nation's Election Board
8 (12 T.O.C. Chapter 1, Article III, Section 1301(A) and (B)); and

9 **WHEREAS,** the Nation's Elections law provides that Election Board members shall be
10 "appointed . . . for a term of five years or until their successors are appointed" and
11 further that "[a]ppointments to the [Election] Board shall be staggered so that the
12 term of office of only one member will end in any single year" (12 T.O.C. Chapter
13 1, Article III, Section 1301(B)); and

14 **WHEREAS,** Camillus Lopez was appointed to the Election Board by Resolution No. 16-591 for
15 a term ending July 31, 2021, and he continues to serve until his successor is
16 appointed; and

17 **WHEREAS,** the Rules Committee recommends that Camillus Lopez be appointed to the
18 Election Board for a term ending July 31, 2026.

19 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council appoints
20 Camillus Lopez to the Election Board for a term beginning on August 1, 2021 and
21 ending July 31, 2026, provided that he shall continue to serve until his successor
22 is appointed.

23 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH
24 day of SEPTEMBER, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;
25 -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by,
26 Article VI, Section 1(b); Article X, Section 7 of the Constitution of the Tohono O'odham Nation,
27 adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy
28 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the
29 Act of June 18, 1934 (48 Stat.984).
