

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Amending Resolution No. 20-335, Approving FY 2020 Tohono O'odham Nation's**  
**Healthcare CARES Act COVID-19 Budget to Extend the Budget Authority into FY 2023)**

**RESOLUTION NO. 22-343**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2) and (3)); and

7 **WHEREAS,** the Tohono O'odham Nation's Healthcare's FY 2020 CARES Act Budgets in the  
8 amount of \$3,519,205.00 was approved by Resolution No. 20-335; and

9 **WHEREAS,** the Tohono O'odham Nation's Healthcare is requesting the budget term be  
10 extended for the CARES Act COVID-19 Budget in the amount of \$298,403.00 which  
11 budget authority under Resolution No. 20-335 expired on May 30, 2022, which  
12 makes it necessary to extend the budget authority into FY 2023 to expend  
13 available funds; and


14 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have  
15 reviewed the FY 2020 Tohono O'odham Nation's Healthcare CARES Act COVID-19  
16 Budget Extending Resolution and recommend its approval.

17 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
18 budget term extension through November 30, 2022 for the FY 2020 Tohono  
19 O'odham Nation's Healthcare CARES Act COVID-19 Budgets in the amount of  
20 \$298,403.00, which has expired May 30, 2022.

21 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
22 Nation chairperson or any designated official is authorized to administer and  
23 expend the FY 2020 Tohono O'odham Nation's Healthcare CARES Act COVID-19  
24 Budget provided that any amendments or modifications shall be submitted for  
25 prior approval by the Tohono O'odham Legislative Council.

26 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15<sup>TH</sup>  
27 day of SEPTEMBER, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;  
28 -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by,  
29 Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by  
30 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
31 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
32 18, 1934 (48 Stat.984).
