

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Appointing Individuals to the Board of Directors for a Mexican Civil Association)**

**RESOLUTION NO. 22-365**

1 **WHEREAS,** the Constitution of the Tohono O'odham Nation vests the Legislative Council with  
2 the authority "to promote, protect and provide for public health, peace, morals,  
3 education and general welfare of the Tohono O'odham Nation and its members"  
4 and "to authorize, charter and regulate public or private corporations and  
5 associations whether organized for profit, or for non-profit or charitable  
6 purposes" (Constitution, Article VI, Section 1(c)(2) and Section 1(b)); and

7 **WHEREAS,** in accordance with Resolution No. 20-331, the Nation's chairperson and vice  
8 chairperson seek approval to create a Mexican civil association; and

9 **WHEREAS,** the Agricultural and Natural Resources Committee reviewed the Plan to Create a  
10 Mexican Civil Association ("Plan"), which is confidential, and recommends that  
11 eight (8) individuals listed on Exhibit A, whose names shall remain confidential,  
12 be appointed to the Board of Directors of the Mexican Civil Association.

13 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council:

- 14 1. appoints the eight (8) individuals listed on Exhibit A, whose names shall  
15 remain confidential, to the Board of Directors of the Mexican Civil  
16 Association; and
- 17 2. authorizes these individuals to undertake all actions necessary to execute  
18 their duties under the Plan; and
- 19 3. requires these individuals to regularly provide an update to the Nation's  
20 Agricultural & Natural Resources Committee and the Legislative Council.

21 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27<sup>th</sup>  
22 day of SEPTEMBER, 2022 at a meeting at which a quorum was present with a vote of 2,423.85 FOR;  
23 237.65 AGAINST; 556.5 [02] NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the  
24 Council by, Article VI, Section 1(b) and Section 1(c)(2) of the Constitution of the Tohono O'odham  
25 Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting  
26 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section  
27 16 of the Act of June 18, 1934 (48 Stat.984).
