

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Additions to the Master List for Eligible Minor Tohono O'odham Members
for the Fourth Per Capita Distribution and Authorizing the Transfer of Funds
to set up a Trust Account at Principal Trust Company)

RESOLUTION NO. 22-373

1 **WHEREAS,** The Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** on June 28, 1997, the Nation's voters approved Initiative No. IN-01-97, the
8 "O'odham Voice on Use of Gaming Revenues" (the "Initiative"), which authorizes
9 per capita payments to the Nation's members provided that sufficient gaming
10 revenues are available; and

11 **WHEREAS,** the Ordinance for the Regulation of Gaming Activities Within the Tohono
12 O'odham Nation (the "Gaming Ordinance") was subsequently amended to
13 authorize per capita distribution payments in accordance with the Initiative
14 (Legislative Council Resolution No. 97-303); and

15 **WHEREAS,** the Legislative Council did adopt the Tohono O'odham Nation Revenue Allocation
16 Plan pursuant to Legislative Council Resolution No. 09-164; and

17 **WHEREAS,** on June 15, 2009, the Tohono O'odham Nation received notice from the Secretary
18 of the Department of Interior that the Tohono O'odham Nation Revenue
19 Allocation Plan was approved; and

20 **WHEREAS,** the Tohono O'odham Nation Department of Membership Services submitted to
21 the Tohono O'odham Legislative Council the Master List for Eligible Minor
22 Tohono O'odham Members for the Fourth Per Capita Distribution ("Master List")
23 for review and approval; and

24 **WHEREAS,** Legislative Council approved the Master List with the initial number of 8,665
25 verified minor members (Resolution Number 09-429); and

26 **WHEREAS,** the Enrollment Program has identified 5 eligible minor members who were left
27 off the Master List for the fourth per capita distribution; and

28 **WHEREAS,** the 5 minor members eligible for the fourth per capita payment did not have the
29 Principal Trust Company account established in accordance with the Principal
30 Trust Agreement, which was approved by Tohono O'odham Legislative Council
31 Resolution No. 06-258; and

1 **WHEREAS, the Nation's Treasurer has calculated the accrued interest due to the eligible**
2 **minor members for the fourth per capita payment.**

3 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 4 **1. Approves the attached list of 5 eligible minor members whose names were left**
5 **off the Master List for Eligible Minor Tohono O'odham Members for the Fourth**
6 **Per Capita Distribution and such names will be incorporated into the Master**
7 **List approved by Legislative Council Resolution No. 09-429.**
- 8 **2. Authorizes the Office of the Treasurer to transfer \$10,000 (5 x \$2000 = \$10,000)**
9 **from the Principal Trust Company Fourth Per Capita Excess Funds Account to**
10 **establish a trust account for each of the minors at Principal Trust Company**
11 **pursuant to the terms of the Trust Agreement approved by Tohono O'odham**
12 **Legislative Council Resolution No. 06-258.**
- 13 **3. Authorizes the Office of the Treasurer to transfer \$4,872.20 from the Principal**
14 **Trust Company Fourth Per Capita Excess Funds Account to pay the accrued**
15 **interest income due for the fourth per capita payment.**
- 16 **4. Authorizes the Chairperson of the Nation or a designated official to execute**
17 **such other documents as may be necessary to implement this resolution.**

18 **BE IT FINALLY RESLOVED by the Tohono O'odham Legislative Council that any future additions**
19 **to the Master List for Eligible Minor Tohono O'odham Members for the Fourth Per**
20 **Capita Distribution is subject to the approval of the Tohono O'odham Legislative**
21 **Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH**
23 **day of OCTOBER, 2022 at a meeting at which a quorum was present with a vote of 2,975.4 FOR;**
24 **~~-0-~~ AGAINST; ~~-0-~~ NOT VOTING; and 242.6[06] ABSENT, pursuant to the powers vested in the**
25 **Council by, Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted**
26 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
27 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
28 **Act of June 18, 1934 (48 Stat.984).**
