

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing Tohono O'odham Ki:Ki Association to Submit a 2022 Indian
Community Development Block Grant Application for Construction of 12
New Affordable Homeownership Housing Units)**

RESOLUTION NO. 22-376

1 **WHEREAS,** the Constitution of the Tohono O'odham Nation vests the Tohono O'odham
2 Legislative Council with the power to "to promote, protect and provide for public
3 health, peace, morals, education and general welfare of the Tohono O'odham
4 Nation and its members" (Constitution, Article VI, Section 1(c)(2)); and

5 **WHEREAS,** the Tohono O'odham Ki:Ki Association ("TOKA") is the Nation's tribally
6 designated housing entity in accordance with the Native American Housing
7 Assistance and Self-Determination Act of 1996, 25 U.S.C. § 4101, et seq., P.L. 104-
8 330, 110 Stat. 4106 ("NAHASDA") and is authorized to receive and administer the
9 Indian Community Development Block Grant ("ICDBG") and to seek other funds
10 to operate and expand affordable housing, and

11 **WHEREAS,** the TOKA wishes to continue providing new affordable housing for Nation's
12 members by submitting a 2022 ICDBG application for \$4,000,000.00 and to
13 leverage those funds with \$675,000.00 of 2024 Indian Housing Block Grant
14 ("IHBG") funds and \$675,000.00 of 2025 IHBG funds for construction of 12 new
15 affordable homeownership housing units for Nation's members; and

16 **WHEREAS,** the FY 2022 Notice of Funding Availability ("NOFA") requires applications include
17 a current Resolution by the Tohono O'odham Legislative Council confirming
18 compliance with ICDBG Citizen Participation requirements and authorizing the
19 submission of the application by the TOKA; and

20 **WHEREAS,** the Nation held public meetings to discuss the ICDBG program and eligible
21 activities including the proposed project and allowed public comments and
22 made modifications to the application as necessary in compliance with 24 C.F.R.
23 § 1003.604(a), and

24 **WHEREAS,** the Housing Committee has reviewed the 2022 ICDBG application and
25 recommends its approval.

26 **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that:

- 27 1. the TOKA is authorized to submit a 2022 application for ICDBG funding in
28 the amount of \$4,000,000.00 and to leverage those funds with \$675,000.00
29 of 2024 IHBG funds and \$675,000.00 of 2025 IHBG funds to construct 12 new
30 affordable homeownership housing units for Nation's members; and

2. the Nation confirms compliance with the ICDBG Citizen Participation requirements of 24 C.F.R. § 1003.604.

BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Nation's chairperson, or any designated official, is authorized and directed to execute all documents necessary for the TOKA to submit a 2022 ICDBG application and any documents that may require the Nation's chairperson's signature post award, including the environmental review.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH day of OCTOBER, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0- AGAINST; [01] NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by, Article VI, Section 1(c)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
