

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving an Extension of the Budget Term of the FY 2022 Executive Branch  
American Rescue Plan Act BIA Funds Budget)**

**RESOLUTION NO. 22-379**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2) and (3)); and**

7 **WHEREAS, the FY 2022 Executive Branch American Rescue Plan Act BIA Budget in the amount**  
8 **of \$4,431,375.50 was approved by Resolution No. 22-098; and**

9 **WHEREAS, the budget term under Resolution No. 22-098 expires on September 30, 2022,**  
10 **which makes it necessary to extend the budget term to September 30, 2023 to**  
11 **expend available funds; and**

12 **WHEREAS, the Executive Branch is requesting the budget's term be extended to September**  
13 **30, 2023; and**

14 **WHEREAS, the Budget and Finance Committee have reviewed the request to extend the**  
15 **budget term of the FY 2022 American Rescue Plan Act BIA Funds Budget through**  
16 **September 30, 2023 and recommend its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
18 **FY 2022 Executive Branch American Rescue Plan Act BIA Budget Amendment No.**  
19 **1, which amends Resolution No. 22-098 to extend the budget authority from**  
20 **September 30, 2022 to September 30, 2023 or until funds have been exhausted.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council authorizes the Tohono**  
22 **O'odham Nation chairperson, or any designated official, is authorized to**  
23 **administer and expend the FY 2022 Executive Branch American Rescue Plan Act**  
24 **BIA budget as amended, provided that any further amendments and**  
25 **modifications shall be submitted for prior approval by the Tohono O'odham**  
26 **Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup>**  
28 **day of OCTOBER, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**  
29 **-0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by,**  
30 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
33 **18, 1934 (48 Stat.984).**
