RESOLUTION NO. 22-390

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members**
3 **(Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2, and**
4 **Article VI, Section 1(h)); and**

5 **WHEREAS, pursuant to Article VI and VII of the Nation's Enrollment Ordinance, the**
6 **Enrollment Committee shall review membership applications and make a**
7 **written recommendation to the Tohono O'odham Legislative Council to approve**
8 **or reject the application (14 Tohono O'odham Code Chapter 1 – Enrollment**
9 **Ordinance); and**

10 **WHEREAS, pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono**
11 **O'odham Legislative Council shall determine eligibility for membership or**
12 **adoption (14 Tohono O'odham Code Chapter 1 – Enrollment Ordinance); and**

13 **WHEREAS, the Enrollment Committee has determined that a number of resolutions**
14 **approving membership and adoption applications misspelled or incorrectly**
15 **listed the names of Nation's members; and**

16 **WHEREAS, the Enrollment Committee recommends that Resolution Nos. 05-148, 05-204, 05-**
17 **368, 06-222, 06-511, 07-075, 07-236, 07-739, 08-324, 10-153, 11-402, 12-085, and 22-**
18 **313 be amended to reflect the correct names for the Nation's members identified**
19 **in the November 2022 Corrected Enrollment Resolution Summary, which is**
20 **incorporated by this reference.**

21 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**
22 **Nos. 05-148, 05-204, 05-368, 06-222, 06-511, 07-075, 07-236, 07-739, 08-324, 10-153,**
23 **11-402, 12-085, and 22-313 are amended upon the effective date of those**
24 **resolutions to reflect the correct names of Nation's members identified in the**
25 **November 2022 Corrected Enrollment Resolution Summary.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH**
27 **day of NOVEMBER, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**

29 **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono O'odham**

31 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
32 **16 of the Act of June 18, 1934 (48 Stat.984).**
