

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 Executive Branch American Rescue Plan Act Budget Amendment No. 1)

RESOLUTION NO. 22-397

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2022 Executive Branch American Rescue Plan Act Budget in the amount of
8 \$170,056,409.00 was approved by Resolution No. 22-077; and

9 **WHEREAS,** the Executive Branch has prepared and submitted for review and approval its FY
10 2022 American Rescue Plan Act Budget Amendment No. 1, which is incorporated
11 by this reference and which will adjust operational line items; and

12 **WHEREAS,** the FY 2022 American Rescue Plan Act Budget Amendment No. 1 will decrease by
13 \$6,983,800.00, from \$170,056,409.00 to \$163,072,609.00; and

14 **WHEREAS,** the Budget and Finance Committee have reviewed the FY 2022 Executive Branch
15 American Rescue Plan Act Budget Amendment No. 1 and recommend its
16 approval.

17 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
18 FY 2022 Executive Branch American Rescue Plan Act Budget Amendment No. 1
19 effective October 1, 2021 ending December 31, 2024, which includes a
20 \$6,983,800.00 decrease from \$170,056,409.00 to \$163,072,609.00 that shall be
21 funded by the American Rescue Plan Recovery Fund.

22 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
23 Nation chairperson or any designated official is authorized to administer and
24 expend the FY 2022 Executive Branch American Rescue Plan Act Budget as
25 amended, provided that any amendments or modifications shall be submitted
26 for prior approval by the Tohono O'odham Legislative Council.

27 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH
28 day of NOVEMBER, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;
29 ~~0~~- AGAINST; ~~0~~- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by,
30 Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by
31 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
32 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
33 18, 1934 (48 Stat.984).


