

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2023 Department of Health and Human Services Division of  
Senior Services Title VI Amendments No. 1)**

**RESOLUTION NO. 22-401**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d) (2)); and**

7 **WHEREAS, the FY 2023 Department of Health and Human Services Division of Senior Services**  
8 **Title VI Budgets totaling the amount of \$265,010.00 were approved by Resolution**  
9 **No. 22-148; and**

10 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**  
11 **review and approval its FY 2023 Title VI Part A, Title VI Part C and Title VI NSIP**  
12 **Amendments No. 1, which is incorporated by this reference, and which will adjust**  
13 **personnel and operational line items and indirect costs; and**

14 **WHEREAS, the FY 2023 Department of Health and Human Services Title VI Budget**  
15 **Amendments No. 1 will increase the original budget from \$265,010.00 to**  
16 **\$619,594.48, a total combined increase of \$354,584.48; and**

17 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**  
18 **reviewed the FY 2023 Department of Health and Human Services Division of**  
19 **Senior Services Title VI Amendments No. 1 and recommend their approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
21 **FY 2023 Department of Health and Human Services Division of Senior Services**  
22 **Title VI Budget Amendments No. 1 effective April 1, 2022, as follows:**

- 23 1. **Title VI Part C Caregivers Budget will increase by \$94,309.85 from**  
24 **\$68,680.00 to \$162,989.85.**
- 25 2. **Title VI Part A Elders Program Budget will increase by \$246,127.04 from**  
26 **\$186,930.00 to \$433,057.04.**
- 27 3. **Title VI NSIP Budget will increase by \$14,147.59 from \$9,400.00 to**  
28 **\$23,547.59.**

29 **for a combined total increase of \$354,584.48, from \$265,010.00 to \$619,594.48, and**  
30 **which shall be funded by the Nation's general fund pending reimbursement**  
31 **from the grantor, the Administration for Community Living, pursuant to Title VI**  
32 **of the Older Americans Act of 1978.**

1 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
2 Nation chairperson or any designated official is authorized to administer and  
3 expend the FY 2023 Department of Health and Human Services Division of Senior  
4 Services Title VI Budgets as amended, provided that any amendments or  
5 modifications shall be submitted for prior approval by the Tohono O'odham  
6 Legislative Council.

7 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup>  
8 day of NOVEMBER, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;  
9 -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by,  
10 Article VI, Section 1(d) (2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by  
11 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
12 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
13 18, 1934 (48 Stat.984).


