

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 21-200, "Approving FY 2022 Department of Health and
Human Services OAA Title VI Consolidated Appropriations Act Budget" to
Extend the Budget Authority into FY 2023)**

RESOLUTION NO. 22-404

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation... and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1 (d) (2)); and

7 **WHEREAS,** the FY 2022 Department of Health and Human Services Division of Senior Services
8 OAA Title VI Consolidated Appropriations Act Budget in the amount of \$40,800.00
9 was approved by Resolution No. 21-200; and

10 **WHEREAS,** the Department of Health and Human Services, Division of Senior Services has
11 submitted for review and approval its request to amend Resolution No. 21-200 in
12 which the budget authority expired on September 30, 2022 to extend budget
13 period to September 30, 2023 to allow for available funds to be expended; and

14 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
15 reviewed and recommend approval of the FY 2023 Department of Health and
16 Human Services, Division of Senior Services, OAA Title VI Consolidated
17 Appropriations Act Budget through September 30, 2023.

18 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council accepts the
19 no cost extension of the OAA Title VI Consolidated Appropriations Act Budget and
20 approves the extension of the budget term of the FY 2023 Department of Health
21 and Human Services, Division of Senior Services, OAA Title VI Consolidated
22 Appropriations Act Budget from January 1, 2021, ending September 30, 2023.

23 **BE IT FINALLY RESOLVED** that Tohono O'odham Legislative Council authorizes the Tohono
24 O'odham Nation chairperson or any designated official to administer and expend
25 the FY 2023 Department of Health and Human Services, Division of Senior
26 Services, OAA Title VI Consolidated Appropriations budget, provided that any
27 amendments or modifications shall be submitted for prior approval by the
28 Tohono O'odham Legislative Council.


