

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2023 Department of Health and Human Services Division of  
Community Health Services Public Health Preparedness COVID-19 Carry  
Forward Budget)**

**RESOLUTION NO. 22-406**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d) (2)); and**

7 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**  
8 **review and approval its FY 2023 Division of Community Health Services Public**  
9 **Health Preparedness COVID-19 Carry Forward Budget, which is incorporated by**  
10 **this reference, in the amount of \$37,448.96 to be funded by the Arizona**  
11 **Department of Health and Human Services; and**

12 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**  
13 **reviewed the FY 2023 Department of Health and Human Services Division of**  
14 **Community Health Services Public Health Preparedness COVID-19 Carry**  
15 **Forward Budget and recommend its approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
17 **FY 2023 Department of Health and Human Services Division of Community Health**  
18 **Services Public Health Preparedness COVID-19 Carry Forward Budget effective**  
19 **March 16, 2022 in the amount of \$37,448.96, which shall be funded by the Arizona**  
20 **Department of Health and Human Services.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
22 **Nation chairperson or any designated official is authorized to administer and**  
23 **expend the FY 2023 Department of Health and Human Services Division of**  
24 **Community Health Services Public Health Preparedness COVID-19 Carry**  
25 **Forward Budget, provided that any amendments or modifications shall be**  
26 **submitted for prior approval by the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup>**  
28 **day of NOVEMBER, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**  
29 **-0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by,**  
30 **Article VI, Section 1(d) (2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
33 **18, 1934 (48 Stat.984).**
