

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Enrollment Resolution Nos. 127-83, 04-109, 05-472, 05-607, 05-711, 08-682,
12-180 and 22-368 to Correct Names and/or Enrollment Numbers of Enrolled Members)

RESOLUTION NO. 22-419

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power to enact laws
2 and ordinances governing the enrollment and adoption of members
3 (Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and
4 Article VI, Section 1(h)); and

5 **WHEREAS,** pursuant to Articles VI and VII of the Nation's Enrollment Ordinance, the
6 Enrollment Committee shall review membership applications and make a
7 written recommendation to the Tohono O'odham Legislative Council to approve
8 or reject the application (14 Tohono O'odham Code Chapter 1 - Enrollment
9 Ordinance); and

10 **WHEREAS,** pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono
11 O'odham Legislative Council shall determine eligibility for membership or
12 adoption; and

13 **WHEREAS,** the Enrollment Program has determined that a number of resolutions approving
14 membership and adoption applications misspelled or incorrectly listed the
15 names of members and/or incorrectly listed enrollment numbers; and

16 **WHEREAS,** the Enrollment Program recommends that Resolution Nos. 127-83, 04-109, 05-
17 472, 05-607, 05-711, 08-682, 12-180 and 22-368 be amended to reflect the correct
18 names and/or enrollment numbers of members identified in the December 2022
19 Corrected Enrollment Resolution Summary, which is incorporated by this
20 reference.

21 **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that Resolution
22 Nos. 127-83, 04-109, 05-472, 05-607, 05-711, 08-682, 12-180 and 22-368 are
23 amended upon the effective date of those resolutions to reflect the correct names
24 and/or enrollment numbers of members identified in the December 2022
25 Corrected Enrollment Resolution Summary.

26 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH
27 day of DECEMBER, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;
28 -0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by,
29 Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono O'odham
30 Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting
31 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section
32 16 of the Act of June 18, 1934 (48 Stat.984).
