

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 Planning and Economic Development Department Roads Program
SXIR Consolidated No. 2 Wa:k Lane and Go:k Ka:wulk Wog Budget Amendment No.1)

RESOLUTION NO. 22-426

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2023 Planning and Economic Development Department Roads Program
8 SXIR Consolidated No. 2 Wa:k Lane and Go:k Ka:wulk Wog Budget in the amount
9 of \$1,931,458.08 was approved by Resolution No. 21-335; and

10 **WHEREAS,** the Planning and Economic Development Department Roads Program has
11 prepared and submitted for review and approval its FY 2023 SXIR Consolidated
12 No. 2 Wa:k Lane and Go:k Ka:wulk Wog Budget Amendment No.1 which is
13 incorporated by this reference and which will adjust operational line items; and

14 **WHEREAS,** the Agricultural and Natural Resources and Budget and Finance Committees
15 have reviewed the FY 2023 Planning and Economic Development Department
16 Roads Program SXIR Consolidated No. 2 Wa:k Lane and Go:k Ka:wulk Wog Budget
17 Amendment No.1 and recommend its approval.

18 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
19 FY 2023 Planning and Economic Development Department Roads Program SXIR
20 Consolidated No. 2 Wa:k Lane and Go:k Ka:wulk Wog Budget Amendment No.1
21 effective October 1, 2021, which will not change the budget total, that shall be
22 funded by the Nation's general fund pending reimbursement by the grantor, the
23 Bureau of Indian Affairs.

24 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
25 Nation chairperson or any designated official is authorized to administer and
26 expend the FY 2023 Planning and Economic Development Department Roads
27 Program SXIR Consolidated No. 2 Wa:k Lane and Go:k Ka:wulk Wog Budget
28 Amendment No.1 as amended, provided that any amendments or modifications
29 shall be submitted for prior approval by the Tohono O'odham Legislative Council.


