

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 Planning and Economic Development Department Roads
Program PIR Road Maintenance Budget Amendment No. 1)**

RESOLUTION NO. 22-428

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation ... and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1 (d) (2)); and

7 **WHEREAS,** the FY 2022 Planning and Economic Development Department Roads Program
8 PIR Road Maintenance Budget in the amount of \$4,655,408.59 was approved by
9 Resolution No. 22-242; and

10 **WHEREAS,** the Planning and Economic Development Department Roads Program has
11 prepared and submitted for review and approval its FY 2023 PIR Road
12 Maintenance Budget Amendment No. 1, which is incorporated by this reference
13 and which will adjust operational line items; and

14 **WHEREAS,** the Planning and Economic Development Department Roads Program will
15 increase the FY 2023 PIR Road Maintenance Budget by \$1,851,699.00 from
16 \$4,655,408.59 to \$6,507,077.59; and

17 **WHEREAS,** the Agricultural and Natural Resources and Budget and Finance Committees
18 have reviewed the FY 2023 Planning and Economic Development Department
19 Roads Program PIR Road Maintenance Budget Amendment No. 1 and
20 recommend its approval.

21 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
22 FY 2023 Planning and Economic Development Department Roads Program PIR
23 Road Maintenance Budget Amendment No. 1 effective March 14, 2022, which
24 includes a \$1,851,699.00 increase from \$4,655,408.59 to \$6,507,077.59 that shall
25 be funded by the Nation's general fund pending reimbursement by the grantor
26 the Bureau of Indian Affairs.

27 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
28 Nation chairperson or any designated official is authorized to administer and
29 expend the FY 2023 Planning and Economic Development Department Roads
30 Program PIR Road Maintenance Budget Amendment No. 1 as amended, provided
31 that any amendments or modifications shall be submitted for prior approval by
32 the Tohono O'odham Legislative Council.


