

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022-2024 Planning and Economic Development Department Roads
Program PIR 2304(1) Ventana Community Loop Budget Amendment No. 1)

RESOLUTION NO. 22-430

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation ... and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2022 Planning and Economic Development Department Roads Program
8 PIR 2304(1) Ventana Community Loop Budget in the amount of \$1,156,963.00 was
9 approved by Resolution No. 22-243 for a budget term of March 1, 2022 through
10 September 30, 2024; and

11 **WHEREAS,** the BIA Western Region Office has awarded the Nation an additional \$168,038.00
12 via Modification No. 1 for Contract A22AV00494, PIR 2304(1) Ventana Community
13 Loop; and

14 **WHEREAS,** the Planning and Economic Development Department Roads Program has
15 prepared and submitted for review and approval its FY 2022-2024 PIR 2304(1)
16 Ventana Community Loop Budget Amendment No. 1, which is incorporated by
17 this reference, and which will adjust operational line item(s) and/or capital line
18 item(s); and

19 **WHEREAS,** the FY 2022-2024 Planning and Economic Development Department Roads
20 Program PIR 2304(1) Ventana Community Loop Budget Amendment No. 1 will
21 increase the FY 2022 Planning and Economic Development Department Roads
22 Program PIR 2304(1) Ventana Community Loop Budget by \$168,038.00 from
23 \$1,156,963.00 to \$1,325,001.00; and

24 **WHEREAS,** the Agricultural and Natural Resources and Budget and Finance Committees
25 have reviewed the FY 2022-2024 Planning and Economic Development
26 Department Road Program PIR 2304(1) Ventana Community Loop Budget
27 Amendment No. 1 and recommend its approval.

28 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
29 FY 2022-2024 Planning and Economic Development Department Road Program
30 PIR 2304(1) Ventana Community Loop Budget Amendment No. 1, effective March
31 1, 2022 through September 30, 2024, which increases the budget by \$168,038.00
32 from \$1,156,963.00 to \$1,325,001.00 which shall be funded by the Nation's general

1 fund pending reimbursement by the grantor, the Bureau of Indian Affairs, as
2 referenced in BIA Modification No. 1 for Contract A22AV00494, PIR 2304 (1)
3 Ventana Community Loop.

4 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
5 Nation chairperson or any designated official is authorized to administer and
6 expend the FY 2022-2024 Planning and Economic Development Department Road
7 Program PIR 2304(1) Ventana Community Loop Budget as amended, provided
8 that any amendments or modifications shall be submitted for prior approval by
9 the Tohono O'odham Legislative Council.

10 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH
11 day of **DECEMBER, 2022** at a meeting at which a quorum was present with a vote of 3,218.0 FOR;
12 -0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by,
13 Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by
14 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
15 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
16 18, 1934 (48 Stat.984).


