

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving December 2022 Amendment to Tohono O'odham Nation
Board Appointment Guidelines)

RESOLUTION NO. 22-439

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the authority to "provide
2 for, appoint, or provide for the appointment of, and prescribe the duties and
3 powers of committees, boards, officers and agents" (Constitution of the Tohono
4 O'odham Nation, Article VI, Section 1(b)); and

5 **WHEREAS,** in order to facilitate a uniform procedure for appointing board members and to
6 ensure vacancies are filled by qualified individuals in a timely manner, the
7 Legislative Council adopted the Tohono O'odham Nation Board Appointment
8 Guidelines by Resolution No. 03-044 and subsequently amended the Board
9 Appointment Guidelines by Resolution No. 14-046; and

10 **WHEREAS,** the Human Resources Development Committee recommends an amendment to
11 the Tohono O'odham Nation Board Appointment Guidelines, which is
12 incorporated by this reference and dated December 2022, to clarify that the
13 appointing authority is responsible for ordering and paying for background
14 investigation reports for qualified candidates; and

15 **WHEREAS,** the Rules Committee has reviewed the December 2022 amendment to the Tohono
16 O'odham Nation Board Appointment Guidelines and recommends approval.

17 **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that it approves
18 the December 2022 amendment to the Tohono O'odham Nation Board
19 Appointment Guidelines.

20 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH
21 day of **DECEMBER, 2022** at a meeting at which a quorum was present with a vote of 3,218.0 FOR;
22 -0- AGAINST; [02] NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by,
23 Article VI, Section 1 (b) of the Constitution of the Tohono O'odham Nation, adopted by the
24 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
25 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
26 18, 1934 (48 Stat.984).
