

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Addition to the Master List for Eligible Minor Tohono O'odham
Members for the Fourth Per Capita Distribution and Authorizing the Transfer of
Funds to set up a Trust Account at Principal Trust Company)

RESOLUTION NO. 23-005

1 **WHEREAS, on June 28, 1997, the Nation's voters approved Initiative No. IN-01-97, the**
2 **"O'odham Voice on Use of Gaming Revenues" (the "Initiative"), which authorizes**
3 **per capita payments to the Nation's members provided that sufficient gaming**
4 **revenues are available; and**

5 **WHEREAS, the Ordinance for the Regulation of Gaming Activities Within the Tohono**
6 **O'odham Nation (the "Gaming Ordinance") was subsequently amended to**
7 **authorize per capita distribution payments in accordance with the Initiative**
8 **(Legislative Council Resolution No. 97-303); and**

9 **WHEREAS, the Legislative Council did adopt the Tohono O'odham Nation Revenue Allocation**
10 **Plan pursuant to Legislative Council Resolution No. 09-164; and**

11 **WHEREAS, on June 15, 2009, the Tohono O'odham Nation received notice from the Secretary of**
12 **the Department of Interior that the Tohono O'odham Nation Revenue Allocation**
13 **Plan was approved; and**

14 **WHEREAS, the Tohono O'odham Nation Department of Membership Services submitted to**
15 **the Tohono O'odham Legislative Council the Master List for Eligible Minor**
16 **Tohono O'odham Members for the Fourth Per Capita Distribution ("Master List")**
17 **for review and approval; and**

18 **WHEREAS, Legislative Council approved the Master List with the initial number of 8,665**
19 **verified minor members (Resolution Number 09-429); and**

20 **WHEREAS, the Enrollment Program has identified one eligible minor member who was left**
21 **off the Master List for the fourth per capita distribution; and**

22 **WHEREAS, the one minor member eligible for the fourth per capita payment did not have the**
23 **Principal Trust Company account established in accordance with the Principal**
24 **Trust Agreement, which was approved by Tohono O'odham Legislative Council**
25 **Resolution No. 06-258; and**

26 **WHEREAS, the Nation's Treasurer has calculated the accrued interest due to the eligible**
27 **minor member for the fourth per capita payment.**

28 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 29 **1. Approves the addition of one eligible Tohono O'odham minor member to**
30 **the Master List for Eligible Minor Tohono O'odham Member for the Fourth**

1 Per Capita Distribution, who is listed in the attached January 2023
2 Addition to the Minor Master List for the Fourth Per Capita Distribution.

- 3 2. Authorizes the Office of the Treasurer to transfer \$2,000.00 from the
4 Principal Trust Company Fourth Per Capita Excess Funds Account to
5 establish a trust account for the minor at Principal Trust Company
6 pursuant to the terms of the Trust Agreement approved by Tohono
7 O'odham Legislative Council Resolution No. 06-258.
- 8 3. Authorizes the Office of the Treasurer to transfer \$1,044.65 from the
9 Principal Trust Company Fourth Per Capita Excess Funds Account to pay
10 the accrued interest income due for the fourth per capita payment.
- 11 4. Authorizes the Chairperson of the Nation or a designated official to
12 execute such other documents as may be necessary to implement this
13 resolution.

14 **BE IT FINALLY RESLOVED** by the Tohono O'odham Legislative Council that any future additions
15 to the Master List for Minor Eligible Members for the Fourth Per Capita
16 Distribution is subject to the approval of the Tohono O'odham Legislative
17 Council.

18 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH
19 day of JANUARY, 2023 at a meeting at which a quorum was present with a vote of 3,218,0 FOR; -0-
20 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by,
21 Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the
22 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
23 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
24 18, 1934 (48 Stat.984).
