

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2023 Department of Health and Human Services Division of Community Health Services Public Health Emergency Preparedness Carry Forward Budget)**

**RESOLUTION NO. 23-009**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section l(d)(2)); and**

7 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**  
8 **review and approval its FY 2023 Division of Community Health Services Public**  
9 **Health Emergency Preparedness Carry Forward Budget, which is incorporated by**  
10 **this reference, in the amount of \$32,189.45 to be funded by the Nation's general**  
11 **fund pending reimbursement from the Arizona Department of Health and**  
12 **Human Services; and**

13 **WHEREAS, the Health and Human Services and Budget and Finance Committees have reviewed**  
14 **the FY 2023 Department of Health and Human Services Division of Community**  
15 **Health Services Public Health Emergency Preparedness Carry Forward Budget**  
16 **and recommend its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
18 **FY 2023 Department of Health and Human Services Division of Community Health**  
19 **Services Public Health Emergency Preparedness Carry Forward Budget, effective**  
20 **July 1, 2022, in the amount of \$32,189.45 which shall be funded by the Nation's**  
21 **general fund pending reimbursement from the Arizona Department of Health**  
22 **and Human Services.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
24 **Na ti on chairperson or any designated official is authorized to administer and**  
25 **expend the FY 2023 Department of Health and Human Services Division of**  
26 **Community Health Services Public Health Emergency Preparedness Carry**  
27 **Forward Budget, provided that any amendments or modifications shall be**  
28 **submitted for prior approval by the Tohono O'odham Legislative Council.**
