

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 Department of Health and Human Services Division of
Community Health Services Public Health Preparedness Budget Amendment No. 1)**

RESOLUTION NO. 23-011

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2023 Department of Health and Human Services Division of Community**
8 **Health Services Public Health Preparedness Budget in the amount of \$80,000.00**
9 **was approved by Resolution No. 22-177; and**

10 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**
11 **review and approval its FY 2023 Division of Community Health Services Public**
12 **Health Preparedness Budget Amendment No. 1, which is incorporated by this**
13 **reference, which will adjust personnel and/or operational line items; and**

14 **WHEREAS, the FY 2023 Department of Health and Human Services Division of Community**
15 **Health Services Public Health Preparedness Budget Amendment No. 1 will not**
16 **change the budget amount of \$80,000.00; and**

17 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
18 **reviewed the FY 2023 Department of Health and Human Services Division of**
19 **Community Health Services Public Health Preparedness Budget Amendment No.**
20 **1 and recommend its approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
22 **FY 2023 Department of Health and Human Services Division of Community Health**
23 **Services Public Health Preparedness Budget Amendment No. 1, effective July 1,**
24 **2022, in the amount of \$80,000.00 which shall be funded by the Arizona**
25 **Department of Health Services.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
27 **Nation chairperson or any designated official is authorized to administer and**
28 **expend the FY 2023 Department of Health and Human Services Division of**
29 **Community Health Services Public Health Preparedness Budget Amendment No.**
30 **1, provided that any amendments or modifications shall be submitted for prior**
31 **approval by the Tohono O'odham Legislative Council.**




