

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2023 Department of Health and Human Services Women, Infants, and Children Program Inter Tribal Council of Arizona Grant Budget Amendment No. 1)

RESOLUTION NO. 23-012

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2023 Department of Health and Human Services Women, Infants, and**
8 **Children Program Inter Tribal Council of Arizona Grant Budget in the amount of**
9 **\$129,540.00 was approved by Resolution No. 22-294; and**

10 **WHEREAS, the Department of Health and Human Services prepared and submitted for**
11 **review and approval its FY 2023 Women, Infants, and Children Inter Tribal**
12 **Council of Arizona Grant Budget Amendment No. 1, which is incorporated by this**
13 **reference, which increases the budget from \$129,540.00 to \$200,000.00, a total**
14 **increase of \$70,460.00; and**

15 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
16 **reviewed the FY 2023 Department of Health and Human Services, Division of**
17 **Community Health Women, Infants, and Children Inter Tribal Council of Arizona**
18 **Grant Budget Amendment No. 1 and recommend its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
20 **FY 2023 Department of Health and Human Services Women, Infants, and Children**
21 **Inter Tribal Council of Arizona Grant Budget Amendment No.1, effective October**
22 **1, 2022, which increases the budget from \$129,540.00 to \$200,000.00, a total**
23 **increase of \$70,460.00, that shall be funded by the Nation's general fund pending**
24 **reimbursement for the grantor, the Inter-Tribal Council of Arizona.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
26 **Nation chairperson or any designated official is authorized to administer and**
27 **expend the FY 2023 Department of Health and Human Services Women, Infants,**
28 **and Children Inter Tribal Council of Arizona Grant Budget as amended, provided**
29 **however, that any amendments or modifications shall be submitted for prior**
30 **approval by the Tohono O'odham Legislative Council.**


