

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 22-140 "Approving FY 2022 Tohono O'odham Nation
Healthcare American Rescue Plan Act Equipment Budget" to extend the
Budget Authority into FY 2023)**

RESOLUTION NO. 23-020

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2) and (3)); and**

7 **WHEREAS, the FY 2022 Tohono O'odham Nation Healthcare American Rescue Plan Act**
8 **Equipment Budget in the amount of \$328,474.00 was approved by Resolution No.**
9 **22-140; and**

10 **WHEREAS, the Tohono O'odham Nation Health Care has submitted for review and approval**
11 **of its FY 2023 American Rescue Plan Act Equipment Budget requesting to amend**
12 **Resolution No. 22-140 to extend the budget period into FY 2023 to allow for**
13 **available funds to be expended; and**

14 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
15 **reviewed the amending resolution and recommend its approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves an**
17 **extension of the budget authority for the FY 2023 Tohono O'odham Nation**
18 **Healthcare American Rescue Plan Act Equipment Budget in the amount of**
19 **\$328,474.00 through September 30, 2023.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
21 **Nation chairperson or any designated official is authorized to administer and**
22 **expend the FY 2023 Tohono O'odham Nation Healthcare American Rescue Plan**
23 **Act Equipment Budget for the period of October 1, 2022 through September 30,**
24 **2023 and the Accounting Office is authorized to post the unexpended balances of**
25 **the budget as of September 30, 2022 as a carryforward to FY 2023 beginning**
26 **October 2022, provided that any amendments or modifications shall be**
27 **submitted for prior approval by the Tohono O'odham Legislative Council.**


