

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the FY 2023 Professional Service Agreement between the  
Tohono O'odham Nation and Arctic IT)**

**RESOLUTION NO. 23-038**

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**  
2 **the power "to consult, negotiate and conclude agreements and contracts on**  
3 **behalf of the Tohono O'odham Nation with Federal, State and local governments**  
4 **and other Indian tribes or their departments, agencies, or political subdivisions,**  
5 **or with private persons or organizations on all matters within the authority of the**  
6 **Tohono O'odham Council" (Constitution, Article VI, Section 1(f)); and**

7 **WHEREAS, the Professional Service Agreement between the Tohono O'odham Nation**  
8 **("Nation") and Arctic IT will allow Arctic IT to provide the Microsoft Dynamics 365**  
9 **("D365") Finance & Supply Chain Management ("FSCM") solution for the period of**  
10 **October 1, 2022 to September 30, 2023; and**

11 **WHEREAS, the Professional Service Agreement is in excess of \$500,000.00 and has been**  
12 **reviewed by the Office of Attorney General as required by Nation's law; and**

13 **WHEREAS, the funding for this agreement comes from the FY 2022 Executive Branch**  
14 **American Rescue Plan Act Budget, as amended, 001-21-6051; and**

15 **WHEREAS, the Budget and Finance Committee has reviewed the Agreement and**  
16 **recommends its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED, that the Tohono O'odham Legislative Council approves the**  
18 **FY 2023 Professional Service Agreement between the Tohono O'odham Nation**  
19 **and Arctic IT in substantially the form attached.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
21 **Nation chairperson or any designated official is authorized to execute and**  
22 **administer the FY 2023 Professional Service Agreement, provided that any**  
23 **amendments shall be submitted for prior approval by the Tohono O'odham**  
24 **Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18<sup>TH</sup>**  
26 **day of JANUARY, 2023 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-**  
27 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by,**  
28 **Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
29 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
30 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**  
31 **(48 Stat.984).**


