

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 Department of Education Recreation Budget Amendment No. 1)

RESOLUTION NO. 23-052

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2023 Department of Education Recreation Budget in the amount of
8 \$3,465,563.03 was approved by Resolution No. 22-295; and

9 **WHEREAS,** the Department of Education has prepared and submitted for review and
10 approval its FY 2023 Recreation Budget Amendment No. 1, which is incorporated
11 by this reference and which will adjust operational and/or personnel line items
12 and create a new line item; and

13 **WHEREAS,** the FY 2023 Department of Education Recreation Budget Amendment No. 1 will
14 not change the original budget amount of \$3,465,563.03; and

15 **WHEREAS,** the Human Resources and Development and Budget and Finance Committees
16 have reviewed the FY 2023 Department of Education Recreation Budget
17 Amendment No. 1 and recommend its approval.


18 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
19 FY 2023 Department of Education Recreation Budget Amendment No. 1 effective
20 October 1, 2022 which does not change the original budget amount of
21 \$3,465,563.03, and shall be funded by the Nation's general fund.

22 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
23 Nation chairperson or any designated official is authorized to administer and
24 expend the FY 2023 Department of Education Recreation Budget as amended,
25 provided that any amendments or modifications shall be submitted for prior
26 approval by the Tohono O'odham Legislative Council.

27 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH
28 day of FEBRUARY, 2023 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;
29 -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by,
30 Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by
31 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
32 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
33 18, 1934 (48 Stat.984).




