

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 Department of Public Safety Department of Corrections
Budget Amendment No. 1)**

RESOLUTION NO. 23-092

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section I(d)(2)); and

7 **WHEREAS,** the FY 2023 Department of Public Safety Department of Corrections Budget in the
8 amount of \$2,550,180.99 was approved by Resolution No. 22-295; and

9 **WHEREAS,** the Department of Corrections has prepared and submitted for review and
10 approval its FY 2023 Budget Amendment No. 1, which is incorporated by this
11 reference, and which will adjust operational and/or personnel line items; and

12 **WHEREAS,** the FY 2023 Department of Public Safety Department of Corrections Budget
13 Amendment No. 1 will not change the amount of the total budget; and

14 **WHEREAS,** the Domestic Affairs and Budget and Finance Committees have reviewed the FY
15 2023 Department of Public Safety Department of Corrections Budget Amendment
16 No. 1 and recommends its approval.

17 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
18 FY 2023 Department of Public Safety Department of Corrections Budget
19 Amendment No. 1, effective October 1, 2022, which shall not change the total
20 amount of the original budget and which shall be funded by the Nation's general
21 fund.

22 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
23 Nation chairperson or any designated official is authorized to administer and
24 expend the FY 2023 Department of Public Safety Department of Corrections
25 Budget as amended, provided that any amendments or modifications shall be
26 submitted for prior approval by the Tohono O'odham Legislative Council.

27 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH
28 day of MARCH, 2023 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-
29 AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by,
30 Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by
31 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
32 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
33 18, 1934 (48 Stat.984).
