

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2023 Sells District North Communities Gaming Revenue Budget  
Amendment No. 1)**

**RESOLUTION NO. 23-117**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,

3 No district council shall expend district funds except pursuant to  
4 budgets authorized under resolutions of the district council and  
5 approved by the Tohono O'odham Council. The management of  
6 these funds shall be only by a treasurer or other authorized officer  
7 of the district council who has furnished a surety bond satisfactory  
8 to the treasurer of the Tohono O'odham Nation, and all  
9 expenditures of these funds shall be by checks signed by such  
10 treasurer or other authorized officer and the chairman or vice  
11 chairman of the district council.

13 **WHEREAS,** the FY 2023 Sells District Gaming Revenue Budgets in the amount of \$4,500,000.00  
14 were authorized by Sells District Resolution No. SD-78-22 and approved by  
15 Legislative Council Resolution No. 22-338; and

16 **WHEREAS,** by Sells District Council Resolution No. SD-37-23, the Sells District has authorized  
17 and submitted for review and approval its FY 2023 Sells District North  
18 Communities Gaming Revenue Budget Amendment No. 1, which is incorporated  
19 by this reference and which will adjust operational and/or personnel items; and

20 **WHEREAS,** the FY 2023 Sells District North Communities Gaming Revenue Budget  
21 Amendment No. 1 will not change the FY 2023 Sells District Gaming Revenue  
22 Budgets amount of \$4,500,000.00; and

23 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2023 Sells District North  
24 Communities Gaming Revenue Budget Amendment No. 1 and recommends its  
25 approval.

26 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
27 FY 2023 Sells District North Communities Gaming Revenue Budget Amendment  
28 No. 1, effective October 1, 2022, which will not change the FY 2023 Sells District  
29 Gaming Revenue Budgets amount of \$4,500,000.00.

30 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2023 Sells  
31 District North Communities Gaming Revenue Budget as amended shall be  
32 managed and expended in accordance with Article IX, Section 7 of the  
33 Constitution of the Tohono O'odham Nation and the Nation's laws, provided that

any amendments or modifications shall be authorized under District Council resolution and submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup> day of APRIL, 2023 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by, Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).


