

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 HICKIWAN DISTRICT SCHUCHULIGK COMMUNITY BUDGET AMENDMENT NO. 1)

RESOLUTION NO. 23-122

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2023 HICKIWAN DISTRICT BUDGETS in the amount of \$3,489,998.22 was
13 authorized by HICKIWAN DISTRICT COUNCIL RESOLUTION NO. HDC-22-017 and
14 approved by Legislative Council Resolution No. 22-328; and

15 **WHEREAS,** by HICKIWAN DISTRICT COUNCIL RESOLUTION RES -23-009, the HICKIWAN DISTRICT
16 Council has authorized and submitted for review and approval its FY 2023
17 HICKIWAN DISTRICT SCHUCHULIGK COMMUNITY BUDGET AMENDMENT NO. 1, which is
18 incorporated by this reference and which will adjust operational and/or
19 personnel line items; and

20 **WHEREAS,** the FY 2023 HICKIWAN DISTRICT SCHUCHULIGK COMMUNITY BUDGET AMENDMENT NO. 1
21 will not change the FY 2023 HICKIWAN DISTRICT SCHUCHULIGK COMMUNITY BUDGET OF
22 \$100,000.00; and

23 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2023 HICKIWAN DISTRICT
24 SCHUCHULIGK COMMUNITY BUDGET AMENDMENT NO. 1 and recommends its
25 approval.

26 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
27 FY 2023 HICKIWAN DISTRICT SCHUCHULIGK COMMUNITY BUDGET AMENDMENT NO. 1
28 effective October 1, 2022, which will not change the FY 2023 HICKIWAN DISTRICT
29 SCHUCHULIGK COMMUNITY BUDGET amount of \$100,000.00 nor the FY 2023 HICKIWAN
30 DISTRICT BUDGET amount of \$3,489,998.22.

31 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2023 HICKIWAN
32 DISTRICT BUDGET as amended shall be managed and expended in accordance with
33 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the

Nation's laws, provided that any amendments or modifications shall be authorized under District Council resolution and submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH day of APRIL, 2023 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by, Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
