

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2024 Department of Education Child Care Services Title XX Budget)

RESOLUTION NO. 23-144

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Education has prepared and submitted for review and**
8 **approval its FY 2024 Child Care Services Title XX Budget, which is incorporated by**
9 **this reference, in the amount of \$106,285.00 to be funded from the Arizona**
10 **Department of Economic Security Planned Social Services Block Grant Title XX**
11 **Program for a period beginning July 01, 2023, through June 30, 2024; and**

12 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**
13 **reviewed the FY 2024 Department of Education Child Care Services Title XX**
14 **Budget and recommend its approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
16 **FY 2024 Department of Education Child Care Services Title XX Budget effective**
17 **July 1, 2023, in amount of \$106,285.00, which shall be funded by the Nation's**
18 **general fund pending reimbursement from the grantor, Department of**
19 **Economic Security Planned Social Services Block Grant Title XX Program.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
21 **Nation chairperson or any designated official is authorized to administer and**
22 **expend the FY 2024 Department of Education Child Care Services Title XX Budget,**
23 **provided that any amendments or modifications shall be submitted for prior**
24 **approval by the Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 02ND**
26 **day of MAY, 2023 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**
27 **~~0~~ AGAINST; ~~0~~ NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by,**
28 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
29 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat.984).**
