

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 Chukut Kuk District Budget Amendment No. 2)**

RESOLUTION NO. 23-151

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2023 Chukut Kuk District Budget in the amount of \$2,504,558.98 was
13 authorized by Chukut Kuk District Council Resolution No. 2022-31 and approved
14 by Legislative Council Resolution No. 22-354 and subsequently amended by
15 Resolution No. 23-120; and

16 **WHEREAS,** by Chukut Kuk District Council Resolution No. 2023-15, the Chukut Kuk District
17 has authorized and submitted for review and approval its FY 2023 Chukut Kuk
18 District Budget Amendment No. 2, which includes the FY 2023 Chukut Kuk District
19 Miguel Community Budget Amendment No. 1, authorized by Chukut Kuk District
20 Council Resolution No. 2023-13, and the FY 2023 Chukut Kuk District Ston Sudagi
21 Community Budget Amendment No. 1, authorized by Chukut Kuk District Council
22 Resolution No. 2023-14 (collectively, the "FY 2023 Chukut Kuk District Budget
23 Amendment No. 2"); and

24 **WHEREAS,** the FY 2023 Chukut Kuk District Budget Amendment No. 2 is incorporated by this
25 reference and will adjust operational and/or personnel line items; and

26 **WHEREAS,** the FY 2023 Chukut Kuk District Miguel Community Budget Amendment No. 1 will
27 increase the FY 2023 Chukut Kuk District Miguel Community Budget by
28 \$172,816.87 from \$40,000.00 to \$212,816.87; and

29 **WHEREAS,** the FY 2023 Chukut Kuk District Ston Sudagi Community Budget Amendment No.
30 1 will increase the FY 2023 Chukut Kuk District Ston Sudagi Community Budget
31 by \$35,804.71 from \$20,000.00 to \$55,804.71; and

32 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2023 Chukut Kuk District
33 Budget Amendment No. 2 and recommends its approval.

1 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
2 **FY 2023 Chukut Kuk District Budget Amendment No. 2 effective October 1, 2022,**
3 **which includes:**

4 **1. the FY 2023 Chukut Kuk District Miguel Community Budget Amendment**
5 **No. 1, which includes a \$172,816.87 increase from \$40,000.00 to**
6 **\$212,816.87, and shall be funded by Chukut Kuk District Miguel**
7 **Community Budget carryover balances as follows:**

- 8 • **FY 2017 gaming carryover funds in the amount of \$27,127.23;**
- 9 • **FY 2022 gaming carryover funds in the amount of \$120,839.62;**
- 10 • **FY 2014 mining carryover funds in the amount of \$11,782.58; and**
- 11 • **FY 2016 mining carryover funds in the amount of \$13,067.44.**

12 **2. the FY 2023 Chukut Kuk District Ston Sudagi Community Budget**
13 **Amendment No. 1 which includes a \$35,804.71 increase from \$20,000.00 to**
14 **\$55,804.71, and shall be funded by Chukut Kuk District Ston Sudagi**
15 **Community Budget carryover balances as follows:**

- 16 • **FY 2020 gaming carryover funds in the amount of \$18,498.42; and**
- 17 • **FY 2021 gaming carryover funds in the amount of \$17,306.29.**


18 **BE IT FURTHER RESOLVED** by the Tohono O'odham Legislative Council that the FY 2023 Chukut
19 **Kuk District Budget Amendment No. 2 will increase the overall FY 2023 Chukut**
20 **Kuk District Budget by \$208,621.58 from \$2,663,767.93 to 2,872,389.51.**

21 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2023 Chukut
22 **Kuk District Budget as amended shall be managed and expended in accordance**
23 **with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and**
24 **the Nation's laws, provided that any amendments or modifications shall be**
25 **authorized by Chukut Kuk District Council Resolution and submitted for prior**
26 **approval by the Tohono O'odham Legislative Council**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03RD**
28 **day of MAY, 2023 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**
29 **~~0~~ AGAINST; ~~0~~ NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by,**
30 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
31 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
32 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**


