

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2024 Planning and Economic Development Department
Real Property Management Revenue Budget)**

RESOLUTION NO. 23-167

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Planning and Economic Development Department has prepared and
8 submitted for review and approval its FY 2024 Real Property Management
9 Revenue Budget, which is incorporated by this reference, in the amount of
10 \$348,000.00 to be funded from the Tohono O'odham Nation's Lease Revenue
11 Account; and

12 **WHEREAS,** the Commerce and Budget and Finance Committees have reviewed the FY 2024
13 Planning and Economic Development Department Real Property Management
14 Revenue Budget and recommend its approval.

15 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
16 **FY 2024 Planning and Economic Development Department Real Property**
17 **Management Revenue Budget effective October 1, 2023, in amount of \$348,000.00,**
18 **which shall be funded by the Tohono O'odham Nation's Lease Revenue Account.**

19 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
20 Nation chairperson or any designated official is authorized to administer and
21 expend the FY 2024 Planning and Economic Development Department Real
22 Property Management Revenue Budget, provided that any amendments or
23 modifications shall be submitted for prior approval by the Tohono O'odham
24 Legislative Council.


25 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23RD
26 day of MAY, 2023 at a meeting at which a quorum was present with a vote of 2,947.3 FOR;
27 -0- AGAINST; -0- NOT VOTING; and 270.7[04] ABSENT, pursuant to the powers vested in the
28 Council by, Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation,
29 adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy
30 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the
31 Act of June 18, 1934 (48 Stat.984).


