

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2024 Department of Education Division of Early Childhood
Development Child and Adult Care Food Program Budget)**

RESOLUTION NO. 23-170

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Education has prepared and submitted for review and
8 approval its FY 2024 Division of Early Childhood Development Child and Adult
9 Care Food Program Budget, which is incorporated by this reference, in the
10 amount of \$52,000.00 to be funded from the Nation's general fund pending
11 reimbursement from the State of Arizona's Department of Education; and

12 **WHEREAS,** the Human Resources Development and Budget and Finance Committees have
13 reviewed the FY 2024 Department of Education Division of Early Childhood
14 Development Child and Adult Care Food Program Budget and recommend its
15 approval.

16 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
17 FY 2024 Department of Education Division of Early Childhood Development Child
18 and Adult Care Food Program Budget effective October 1, 2023, in amount of
19 \$52,000.00, which shall be funded by the Nation's general fund pending
20 reimbursement from the State of Arizona's Department of Education.

21 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
22 Nation chairperson or any designated official is authorized to administer and
23 expend the FY 2024 Department of Education Division of Early Childhood
24 Development Child and Adult Care Food Program Budget, provided that any
25 amendments or modifications shall be submitted for prior approval by the
26 Tohono O'odham Legislative Council.


27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24TH**

30 **Council by, Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation,**
31 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
32 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
33 **Act of June 18, 1934 (48 Stat.984).**


