

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2024 Department of Health and Human Services Division of  
Child Welfare Title IV-B Subparts 1 and 2 Budgets)**

**RESOLUTION NO. 23-184**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**  
8 **review and approval its FY 2024 Division of Child Welfare Title IV-B Subpart 1**  
9 **Budget, in the amount of \$143,057.00 to be funded by the Stephanie Tubbs Jones**  
10 **Child Welfare Program and Title IV-B Subpart 2 Budget, in the amount of**  
11 **\$213,727.00 to be funded by the Promoting Safe and Stable Families Program,**  
12 **which are incorporated by these references; and**

13 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**  
14 **reviewed the FY 2024 Department of Health and Human Services Division of Child**  
15 **Welfare Title IV-B Subparts 1 and 2 Budgets and recommend their approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
17 **FY 2024 Department of Health and Human Services Division of Child Welfare Title**  
18 **IV-B Subpart 1 Budget effective October 1, 2023 in amount of \$143,057.00, which**  
19 **shall be funded by the Stephanie Tubbs Jones Child Welfare Services Program,**  
20 **and the Title IV-B Subpart 2 Budget effective October 1, 2023 in the amount of**  
21 **\$213,727.00, which shall be funded by the Nation's general fund pending**  
22 **reimbursement from the Promoting Safe and Stable Families Program.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
24 **Nation chairperson or any designated official is authorized to administer and**  
25 **expend the FY 2024 Department of Health and Human Services Division of Child**  
26 **Welfare Title IV-B Subparts 1 and Subparts 2 Budgets, provided that any**  
27 **amendments or modifications shall be submitted for prior approval by the**  
28 **Tohono O'odham Legislative Council.**
