

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2024 Department of Health and Human Services Division of
Community Health Services Public Health Emergency Preparedness Budget)**

RESOLUTION NO. 23-188

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for
8 review and approval its FY 2024 Division of Community Health Services Public
9 Health Emergency Preparedness Budget, which is incorporated by this reference,
10 in the amount of \$80,000.00 to be funded by the Nation's general fund pending
11 reimbursement by the grantor, Arizona Department of Health and Human
12 Services; and

13 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
14 reviewed the FY 2024 Department of Health and Human Services Division of
15 Community Health Services Public Health Emergency Preparedness Budget and
16 recommend its approval.

17 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
18 FY 2024 Department of Health and Human Services Division of Community Health
19 Services Public Health Emergency Preparedness Budget effective July 1, 2023
20 through June 30, 2024, in amount of \$80,000.00, which shall be funded by the
21 Nation's general fund pending reimbursement by the grantor, Arizona
22 Department of Health and Human Services.

23 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
24 Nation chairperson or any designated official is authorized to administer and
25 expend the FY 2024 Department of Health and Human Services Division of
26 Community Health Services Public Health Emergency Preparedness Budget,
27 provided that any amendments or modifications shall be submitted for prior
28 approval by the Tohono O'odham Legislative Council.




