

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2024 Legislative Branch Budget)**

**RESOLUTION NO. 23-193**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Legislative Branch has prepared and submitted for review and approval its FY  
8 2024 Legislative Branch Budget, which is incorporated by this reference, in the  
9 amount of \$5,610,093.46 to be funded from the Nation's general fund; and


10 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2024 Legislative Branch  
11 Budget and recommends its approval.

12 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
13 FY 2024 Legislative Branch Budget effective October 1, 2023 in the amount of  
14 \$5,610,093.46, which shall be funded by the Nation's general fund.

15 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
16 Legislative chairperson or any designated official is authorized to administer and  
17 expend the FY 2024 Legislative Branch Budget, provided that any modifications  
18 shall be submitted to the Budget and Finance Committee for approval on behalf  
19 of the Legislative Council and amendments shall be submitted for prior approval  
20 by the Tohono O'odham Legislative Council.

21 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 25<sup>TH</sup>  
22 day of MAY, 2023 at a meeting at which a quorum was present with a vote of 2,947.3 FOR;  
23 ~~0~~ AGAINST; ~~0~~ NOT VOTING; and 270.7 [05] ABSENT, pursuant to the powers vested in the  
24 Council by, Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation,  
25 adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy  
26 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the  
27 Act of June 18, 1934 (48 Stat.984).
