

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2024 Tribal Employment Rights Commissioners Budget)**

RESOLUTION NO. 23-194

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Tribal Employment Rights Commissioners has prepared and submitted for**
8 **review and approval its FY 2024 Tribal Employment Rights Commissioners**
9 **("TERO Commissioners") Budget, which is incorporated by this reference, in the**
10 **amount of \$128,511.89 to be funded from the TERO Commission Fees; and**

11 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**
12 **reviewed the FY 2024 Tribal Employment Rights Commissioners Budget and**
13 **recommend its approval.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
15 **FY 2024 Tribal Employment Rights Commissioners Budget effective October 1,**
16 **2023 in amount of \$128,511.89 which shall be funded by the Tribal Employment**
17 **Commission Fees.**

18 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
19 **Nation chairperson or any designated official is authorized to administer and**
20 **expend the FY 2024 Tribal Employment Rights Commissioners Budget, provided**
21 **that any amendments or modifications shall be submitted for prior approval by**
22 **the Tohono O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 25TH**
24 **day of MAY, 2023 at a meeting at which a quorum was present with a vote of 2,947.3 FOR;**
25 **~~0~~ AGAINST; ~~0~~ NOT VOTING; and 270.7 [05] ABSENT, pursuant to the powers vested in the**
26 **Council by, Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation,**
27 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
28 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
29 **Act of June 18, 1934 (48 Stat.984).**
