

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 Department of Health and Human Services Division of Family Assistance
Low Income Home Energy Assistance Program ("LIHEAP") Carry Forward Program Budget)

RESOLUTION NO. 23-215

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d) (2)); and**

7 **WHEREAS, the Department of Health and Human Services Division of Family Assistance has**
8 **prepared and submitted for review and approval its FY 2023 LIHEAP Carry**
9 **Forward Program Budget, which is incorporated by this reference, in the amount**
10 **of \$75,118.00 to be funded from the Arizona Department of Economic Security,**
11 **Community Action Services Program; and**

12 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
13 **reviewed the FY 2023 Department of Health and Human Services Division of**
14 **Family Assistance LIHEAP Carry Forward Program Budget and recommend its**
15 **approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
17 **FY 2023 Department of Health and Human Services Division of Family Assistance**
18 **LIHEAP Carry Forward Program Budget, effective July 1, 2022 in the amount of**
19 **\$75,118.00, which shall be funded from the Arizona Department of Economic**
20 **Security, Community Action Services Program.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
22 **Nation chairperson or any designated official is authorized to administer and**
23 **expend the FY 2023 Department of Health and Human Services Division of Family**
24 **Assistance LIHEAP Carry Forward Program Budget, provided that any**
25 **amendments or modifications shall be submitted for prior approval by the**
26 **Tohono O'odham Legislative.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH**
28 **day of JUNE, 2023 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**
29 **-0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by,**
30 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
33 **18, 1934 (48 Stat.984).**
