

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 Professional Services Agreement between the Tohono
O'odham Judicial Branch and Tyler Technologies, Inc.)**

RESOLUTION NO. 23-224

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**
2 **the authority to "consult, negotiate and conclude agreements and contracts on**
3 **behalf of the Tohono O'odham Nation with . . . private persons or organizations**
4 **on all matters within the authority of the Tohono O'odham Council"**
5 **(Constitution, Article VI, Section 1(f)); and**

6 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
7 **within the exclusive control of the Tohono O'odham Nation ... and to appropriate**
8 **these funds for the benefit of the nation and its members" provided that "[a]ll**
9 **expenditures of these funds shall be pursuant to appropriations or budgets"**
10 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
11 **Nation, Article VI, Section 1(d)(2)); and**

12 **WHEREAS, the Tohono O'odham Nation's ("Nation") Judicial Branch desires to purchase a**
13 **case management software system from Tyler Technologies, Inc., for the Judicial**
14 **Branch; and**

15 **WHEREAS, the Judicial Branch has prepared and submitted an agreement for the purchase**
16 **and implementation of the software; and**

17 **WHEREAS, Tyler Technologies, Inc., proposes to charge a one-time cost of \$451,925.00 for the**
18 **software, licensing fees, installation, and first year of maintenance and service;**
19 **and**

20 **WHEREAS, the Judicial Branch proposes to pay this amount from the Judicial Branch's**
21 **American Rescue Plan Act Budget, passed by Resolution No. 22-070 ("ARPA**
22 **funds"); and**

23 **WHEREAS, this Agreement exceeds the amount the Chief Judge is authorized to negotiate,**
24 **execute, and conclude under 26 Tohono O'odham Code Chapter 1, Article 4,**
25 **Section 1404(B) of the Nation's Code, and therefore, Legislative Council approval**
26 **is required; and**

27 **WHEREAS, the Nation's Judiciary Committee has reviewed the Agreement and recommends**
28 **its approval.**

29 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
30 **FY 2023 Professional Services Agreement between the Tohono O'odham Judicial**
31 **Branch and Tyler Technologies, Inc., for a one-time cost of \$451,925.00 for the**
32 **software and its implementation which will be paid for with ARPA funds.**

4 **his delegate, is authorized to approve and execute the FY 2023 Professional**
5 **Services Agreement between the Tohono O'odham Judicial Branch and Tyler**
6 **Technologies, Inc., as described herein, provided that any amendments must be**
7 **submitted to the Tohono O'odham Legislative Council for prior approval.**

8 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH**
9 **day of JUNE, 2023 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**
10 **-0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by,**
11 **Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
12 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
13 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
14 **(48 Stat.984).**
