

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Amending Resolution No. 22-401 "Approving Department of Health and Human Services Senior Services FY 2023 Title VI Part A, Title VI Part C and Title VI Nutrition Services Incentive Program Budgets" extending the Budget Authority into FY 2024)**

**RESOLUTION NO. 23-230**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2) and (3)); and

7 **WHEREAS,** the FY 2023 Department of Health and Human Services Senior Services Title VI  
8 Part A, Title VI Part C and Title VI Nutrition Services Incentive Program Budgets  
9 in the amount of \$265,010.00 was approved by Resolution No. 22-148; and

10 **WHEREAS,** by Resolution No. 22-401 the FY 2023 Department of Health and Human Services  
11 Title VI Part A, Title VI Part C and Title VI Nutrition Services Incentive Program  
12 Budgets were increased by \$354,584.48 from \$265,010.00 to \$619,594.48 in which  
13 the budget authority expired on March 31, 2023; and

14 **WHEREAS,** the Department of Health and Human Services has submitted for review and  
15 approval its FY 2023 Title VI Part A, Title VI Part C and Title VI Nutrition Services  
16 Incentive Program Budgets, requesting to amend Resolution No. 22-401 to extend  
17 the budget period to expire on March 31, 2024 to allow for available funds to be  
18 expended; and

19 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have  
20 reviewed FY 2023 Department of Health and Human Services Senior Services Title  
21 VI Part A, Title VI Part C, and Title VI Nutrition Services Incentive Program Budget  
22 Extending Resolution and recommends its approval.

23 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves an  
24 extension of the budget term for the FY 2023 Department of Health and Human  
25 Services Title VI Budgets in the aggregate amount of \$619,594.48 through March  
26 31, 2024.

27 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
28 Nation chairperson or any designated official is authorized to administer and  
29 expend the FY 2023 Department of Health and Human Services Division of Senior  
30 Services Title VI Budgets as amended, provided that any amendments or


