

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 Department of Public Safety Fire Department Fire
Capital Project Budget Amendment No. 1)**

RESOLUTION NO. 23-243

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2021 Department of Public Safety Fire Department Fire Capital Project
8 Budget Amendment No. 1 in the amount of \$4,699,533.40 was approved by
9 Resolution No. 20-351; and

10 **WHEREAS,** Resolution No. 21-425 extended the FY 2021 Department of Public Safety Fire
11 Department Capital Project Budget until September 30, 2022 into FY 2022 and
12 authorizing the Accounting Department "to post the unexpended balances of the
13 budget in the amount of \$3,810,915.07 as a carry forward in FY 2022 beginning
14 October 1, 2021; and

15 **WHEREAS,** Resolution No. 22-245 extended FY 2022 Department of Public Safety Fire
16 Department Capital Project Budget into FY 2022-2023 to expire until September
17 30, 2023 with no change in the budget amount of \$3,810,915.07; and

18 **WHEREAS,** the Department of Public Safety Fire Department has prepared and submitted for
19 review and approval its FY 2023 Fire Capital Project Budget Amendment No. 1,
20 which is incorporated by this reference and which will adjust operational line
21 items; and

22 **WHEREAS,** the FY 2023 Department of Public Safety Fire Department Fire Capital Project
23 Budget will remain the same at \$3,810,915.07; and

24 **WHEREAS,** the Domestic Affairs and Budget and Finance Committees have reviewed the FY
25 2023 Department of Public Safety Fire Department Fire Capital Project Budget
26 Amendment No. 1 and recommend its approval.

27 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
28 FY 2023 Department of Public Safety Fire Department Fire Capital Project Budget
29 Amendment No. 1 effective October 1, 2021, which the budget total of
30 \$3,810,915.07 will remain the same.

31 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
32 Nation chairperson or any designated official is authorized to administer and
