

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2023 Department of Natural Resources Veterinary Program  
Budget Amendment No. 1)**

**RESOLUTION NO. 23-262**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2023 Department of Natural Resources Veterinary Program Budget in the**  
8 **amount of \$530,742.43 was approved by Resolution No. 22-295; and**

9 **WHEREAS, the Department of Natural Resources Veterinary Program has prepared and**  
10 **submitted for review and approval its FY 2023 Budget Amendment No. 1, which is**  
11 **incorporated by this reference and which will adjust operational line and capital**  
12 **line items; and**

13 **WHEREAS, the Agriculture and Natural Resources and the Budget and Finance Committees**  
14 **of the Tohono O'odham Legislative Council have reviewed the FY 2023**  
15 **Department of Natural Resources Veterinary Program Budget Amendment No. 1**  
16 **and recommend its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
18 **FY 2023 Department of Natural Resources Veterinary Program Budget**  
19 **Amendment No. 1 with no change to the overall budgeted amount.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
21 **Nation chairperson or any designated official is authorized to administer and**  
22 **expend the FY 2023 Department of Natural Resources Veterinary Program Budget**  
23 **as amended, provided however, that any amendments or modifications shall be**  
24 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup>**  
26 **day of JULY, 2023 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**  
27 **~~0~~ AGAINST; ~~0~~ NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by,**  
28 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
29 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
31 **18, 1934 (48 Stat.984).**
