

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2023 Department of Health and Human Services "Get Fit. Don't Quit!"**  
**Apedag Program Budget)**

**RESOLUTION NO. 23-270**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for  
8 review and approval its FY 2023 "Get Fit. Don't Quit!" Apedag Program Budget  
9 which is incorporated by this reference, in the amount of \$10,736.41 to be funded  
10 by donations from Blue Cross Blue Shield of Arizona, the Tohono O'odham  
11 Gaming Enterprise and Bhaji, Inc.; and

12 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have  
13 reviewed the FY 2023 Department of Health and Human Services "Get Fit. Don't  
14 Quit!" Apedag Program Budget and recommend its approval.

15 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
16 FY 2023 Department of Health and Human Services "Get Fit. Don't Quit!" Apedag  
17 Program Budget, effective October 1, 2022 in the amount of \$10,736.41, which  
18 shall be funded from funds donated by Blue Cross Blue Shield of Arizona, the  
19 Tohono O'odham Gaming Enterprise and Bhaji, Inc.

20 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
21 Nation chairperson or any designated official is authorized to administer and  
22 expend the FY 2023 Department of Health and Human Services "Get Fit. Don't  
23 Quit!" Apedag Program Budget provided that any amendments or modifications  
24 shall be submitted for prior approval by the Tohono O'odham Legislative Council.

25 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup>  
26 day of JULY, 2023 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;  
27 -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by,  
28 Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by  
29 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
30 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
31 18, 1934 (48 Stat.984).
