

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 Office of the Treasurer Budget Amendment No. 2)**

2 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
3 **within the exclusive control of the Tohono O'odham Nation, and to appropriate**
4 **these funds for the benefit of the Nation and its members" provided that "[a]ll**
5 **expenditures of these funds shall be pursuant to appropriations or budgets"**
6 **authorized by resolution or ordinance (Constitution, Article VI, Section 1(d)(2));**
7 **and**

8 **WHEREAS, the Legislative Council approved FY 2023 Office of the Treasurer Budget by**
9 **Resolution No. 22-295, the budget amount was later amended to \$1,596,386.79 by**
10 **Resolution No. 22-446; and**

11 **WHEREAS, the Office of the Treasurer has prepared and submitted for review and approval**
12 **its FY2023 Office of the Treasurer Budget Amendment No. 2, which is**
13 **incorporated by this reference; and**

14 **WHEREAS, the FY2023 Office of the Treasurer Budget Amendment No. 2 will not change the**
15 **overall budget amount of \$1,596,386.79; and**

16 **WHEREAS, the Budget and Finance Committee has reviewed the FY2023 Office of the**
17 **Treasurer Budget Amendment No. 2 and recommends its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
19 **FY2023 Office of the Treasurer Budget Amendment No. 2 effective October 1, 2022**
20 **which does not change the overall budget amount of \$1,596,386.79, and shall be**
21 **funded by the Nation's general fund.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
23 **Nation chairperson or any designated official is authorized to administer and**
24 **expend the FY 2023 Office of the Treasurer Budget as amended, provided that any**
25 **amendments or modifications shall be submitted for prior approval by the**
26 **Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH**
28 **day of JULY, 2023 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**
29 **-0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by,**
30 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
31 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
33 **18, 1934 (48 Stat.984).**
