| 12 | | A member of the Nation may relinquish his membership in the |
| 13 | | Nation by submitting a written statement clearly expressing an |
| 14 | | intent to relinquish his membership to the Council, a copy of |
| 15 | | which must be served on the committee. The written statement |
| 16 | | must be signed by the person wishing to relinquish his membership |
| 17 | 1 | or, if a minor or incompetent, by the parent(s), guardian or other |
| 18 | | person legally authorized to act on his behalf. Relinquishment |
| 19 | | does not require the approval of the Council, but is effective upon |
| 20 | | receipt of the statement by the Council and cannot be subsequently |
| 21 | | denied. Upon recognition by the Council that the individual has |
| 22 | | renounced his membership, his name shall be deleted from the |
| 23 | | membership roll. |
| 24 | NOW, THE | REFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby |
| 25 | | recognizes that 02 individuals identified in the August 2023 Relinquishment List |
