

**RESOLUTION OF THE TOHONO O’ODHAM LEGISLATIVE COUNCIL
(Approving and Accepting the Arizona Department of Economic Security for
Workforce Innovation and Opportunity Act Title 1B Intergovernmental
Agreement Amendment No. 2)**

RESOLUTION NO. 23-300

1 **WHEREAS, the Tohono O’odham Council vests the Legislative Council with the power “to**
2 **consult, negotiate, and conclude agreements and contracts on behalf of the**
3 **Tohono O’odham Nation with Federal, State and local governments and other**
4 **Indian tribes or their departments, agencies, or political subdivisions, or with**
5 **private persons or organizations on all matters within the authority of the**
6 **Tohono O’odham Council” (Constitution of the Tohono O’odham Nation Article**
7 **VI, Section 1(f)); and**

8 **WHEREAS, in 2021, the Tohono O’odham Nation Legislative Council passed Resolution No.**
9 **21-343, which approved an Intergovernmental Agreement (“IGA”) (ADES Contract**
10 **Number DI21-002302) with the Arizona Department of Economic Security for**
11 **Workforce Innovation and Opportunity Act (“WIOA”) Title 1B; and**

12 **WHEREAS, in 2022, the Tohono O’odham Nation Legislative Counsel passed Resolution No.**
13 **22-396, which approved Amendment No. 1 to the IGA; and**

14 **WHEREAS, the Department of Education has submitted for review and approval the Arizona**
15 **Department of Economic Security WIOA Title 1B IGA Amendment No. 2,**
16 **incorporated by this reference, which will increase the contract reimbursement**
17 **ceiling by \$594,996.00, from \$1,542,160.00 to \$2,137,156.00, for the period of April**
18 **01, 2022 through June 30, 2024; and**

19 **WHEREAS, the Human Resources Development Committee has reviewed the Arizona**
20 **Department of Economic Security WIOA Title 1B IGA Amendment No. 2 and**
21 **recommends its approval.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O’odham Legislative Council approves and**
23 **accepts the Arizona Department of Economic Security for Workforce Innovation**
24 **and Opportunity Act Title 1B Intergovernmental Agreement Amendment No. 2.**

25 **BE IT FINALLY RESOLVED by the Tohono O’odham Legislative Council that the Tohono O’odham**
26 **Nation chairperson or any designated official is authorized to execute**
27 **Amendment No. 2, provided however, that any further amendments or**
28 **modifications shall be submitted for prior approval by the Tohono O’odham**
29 **Legislative Council.**
