

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Enrollment Resolution Nos. 74-81, 06-328, 07-075, 09-167, and
22-125 to Correct Names and/or Dates of Birth of Enrolled Members)**

RESOLUTION NO. 23-333

1 **WHEREAS,** **the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members (Article II,**
3 **Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono**
4 **O'odham Nation); and**

5 **WHEREAS,** **Articles VI and VII of the Nation's Enrollment Ordinance provide that the**
6 **Enrollment Committee is responsible for reviewing enrollment applications and**
7 **making written recommendations to the Legislative Council regarding the**
8 **eligibility of applicants (14 Tohono O'odham Code Chapter 1); and**

9 **WHEREAS,** **Article VIII of the Nation's Enrollment Ordinance provides that the Tohono**
10 **O'odham Legislative Council shall determine whether an application is approved**
11 **for membership and its determination, along with the resolution number and**
12 **date of enactment, shall be provided to the applicant (14 Tohono O'odham Code**
13 **Chapter 1); and**

14 **WHEREAS,** **the Enrollment Program has determined that a number of resolutions approving**
15 **membership and adoption applications misspelled or incorrectly listed the**
16 **names and/or dates of birth of members; and**

17 **WHEREAS,** **the Enrollment Committee recommends that Resolution Nos. 74-81, 06-328, 07-**
18 **075, 09-167, and 22-125 be amended to reflect the correct names and/or dates of**
19 **birth for the members identified in the September 2023 Corrected Enrollment**
20 **Resolution Summary, which is incorporated by this reference.**

21 **NOW THEREFORE BE IT RESOLVED** by the Tohono O'odham Legislative Council that Resolution
22 **Nos. 74-81, 06-328, 07-075, 09-167, and 22-125 are amended upon the effective**
23 **date of those resolutions to reflect the correct names and/or dates of birth of**
24 **members identified in the September 2023 Corrected Enrollment Resolution**
25 **Summary.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH**
27 **day of SEPTEMBER 2023 at a meeting at which a quorum was present with a vote of 3,005.7 FOR;**
28 **~~-0-~~ AGAINST; ~~-0-~~ NOT VOTING; and 257.6 [05] ABSENT, pursuant to the powers vested in the**
29 **Council by, Article II, Section 1 and 2 and Article VI, Section 1(h) of the Constitution of the**
30 **Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and**
31 **approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,**
32 **1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**
