

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2023 Hewel Ni'ok KOHN Corporation for Public Broadcasting  
Community Service Grant Restricted Budget Amendment No. 1)**

**RESOLUTION NO. 23-348**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2023 Hewel Ni'ok KOHN Corporation for Public Broadcasting Community**  
8 **Service Grant Restricted Budget in the amount of \$105,437.67 was approved by**  
9 **Resolution No. 22-272; and**

10 **WHEREAS, the Hewel Ni'ok has prepared and submitted for review and approval its FY 2023**  
11 **Budget Amendment No. 1, which is incorporated by this reference and which will**  
12 **adjust operational and/or personnel line items; and**

13 **WHEREAS, the FY 2023 Hewel Ni'ok KOHN Corporation for Public Broadcasting Community**  
14 **Service Grant Restricted Budget Amendment No. 1 will decrease the FY 2023**  
15 **Hewel Ni'ok KOHN Corporation for Public Broadcasting Community Service**  
16 **Grant Restricted Budget by \$29,692.99 from \$105,437.67 to \$75,744.68; and**

17 **WHEREAS, the Cultural Preservation and Budget and Finance Committees have reviewed the**  
18 **FY 2023 Hewel Ni'ok KOHN Corporation for Public Broadcasting Community**  
19 **Service Grant Restricted Budget Amendment No. 1 and recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
21 **FY 2023 Hewel Ni'ok KOHN Corporation for Public Broadcasting Community**  
22 **Service Grant Restricted Budget Amendment No. 1 effective October 1, 2022,**  
23 **which decreases budget by \$29,692.99 from \$105,437.67 to \$75,744.68 that shall be**  
24 **funded by FY2023 Hewel Ni'ok KOHN CPB CSG final allocation and FY 2022 carry**  
25 **forward funds.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
27 **Nation chairperson or any designated official is authorized to administer and**  
28 **expend the FY 2023 Hewel Ni'ok KOHN Corporation for Public Broadcasting**  
29 **Community Service Grant Restricted Budget as amended, provided that any**  
30 **amendments or modifications shall be submitted for prior approval by the**  
31 **Tohono O'odham Legislative Council.**
